QUESTION: RFQ, Section 2.8, Page 5 and Section 5.1, Page 14 – The RFQ specifies resumes are required for key personnel on page 5 and each team member on page 14. Are resumes required for key personnel or for each team member involved with the project?

ANSWER: *Please submit the resumes for each key personnel and team member that will be involved in the project.*

QUESTION: RFQ, Section 4.1, Page 13] – The Request for Qualification Cover Sheet form is not provided at the end of the RFQ. What is the Request for Qualification Cover Sheet that is required with the submittal?

ANSWER: *This would be considered the first page of the RFQ itself*

QUESTION: RFQ, Page 1 and Section 3.2, Page 7 – Page 1 says the RFQ deadline is 3:00pm and Page 7 says 3:30pm. What time is the RFQ due on 10/24?

ANSWER: *RFQ closes at 3:30PM local time on October 24, 2019.*

QUESTION: RFQ, Page 1 and Walton County website for bid postings– The RFQ says 1 original and 6 copies, but the posting on the website says 1 original and 5 copies. How many copies of the Statement of Qualifications are required?

ANSWER: *One original (please mark original) and five (5) copies.*

QUESTION: RFQ, Section 5.1, Page 13] – Under the ‘Experience’ part of the ‘Criteria’ section, it states to “describe in detail your firm’s expertise in similar projects or solid waste disposal facility.” The RFQ states this project pertains to constructing water and sewer service along US 331.

ANSWER: *No, this language was inserted in ERROR. Please DISREGARD.*
